School will reply to say if the absence has been authorised or not

(Requests for leave of absence for a family holiday are unlikely to be authorised unless the headteacher considers there to be exceptional and/or unavoidable circumstances. Please refer to the school policy on the website).



You may receive a warning letter or the school can request a Fixed Penalty Notice if you take absence despite it not being authorized.

(School is **expected** to request a fixed penalty notice to be issued, in line with 'City of York Code of Conduct for the use of Education Related Penalty Notices'. This can be found on the council website.)



The Local Authority may issue a Fixed Penalty Notice following a request by the school.
